# Nebraska Electronic Behavioral Health Information Network (eBHIN)

The State of Nebraska is leading the nation in development of a network which will enable behavioral healthcare providers in Region 5 to share patient information electronically. This project has been in the works for several years and participants are looking forward to implementing the network as early as March, 2011. This health information exchange differs from others being developed and implemented throughout the US in that it only deals with behavioral health information. Understandably, one of the major focuses of the project has been to ensure the privacy and security of the information. This is evidenced by the group and security of the information. This is evidenced by the group and security of the information. model, which allows the patient to decide whether or not their information will be available to other network providers. Operating features include a centralized data repository and standardized patient record exchange, compliance with HIPAA & CFR42 regulations, and use of a CCHIT certified electronic medical record system (software developed by NextGen Healthcare Information Systems).

Some key stakeholders who have been involved in the development of the network include: Magellan Behavioral Health, Heartland Community Health Network, The UN Public Policy Center, NAMI, Bryan LGH Medical Center, Lutheran Family Services, SE Rural Physicians Alliance, Community Mental Health Center, Blue Valley Mental Health Center, and Region V Systems.

While the project is currently centered in Region 5, the eBHIN is a new kind of private not for profit organization independently operated and not part of Region V Systems. The long range plan is to eventually include other Regions within the State of Nebraska in the eBHIN. For further information you may contact Wende Baker. Network Director, at 402-441-4388.
